Terms & Conditions of Business

1. The Company reserves rights to make any alteration in the prices and Terms & Conditions without any prior notice.
2. The price list supersedes all earlier price list.
3. Terms of supply.
 - a. Goods worth Rs 2,000/- or more will be dispatched by motor transport to the nearest centre.
 - b. All the packing charges and freight will be charged if the goods are sent by Post Parcel or by Air, wheather the order is from a distributor or any other customer.
 - c. Railway Receipt or Motor Transport Receipt will be forwarded through Bank. Charges will be borne by the party.
 - d. In the event of an order being cancelled or document sent through Bank being dishonored or bill not being accepted by the party, all expenses arising thereof will be debited to the party.
 - e. Untill the value of the goods dispatched is not paid in full, company will have full rights and lien over those goods.
 - f. The Company will not be responsible for any breakage, leakage, spoilage or damage in transit. However under exceptional circumstance, the Company may at its discretion exchange the broken, damaged goods, provided the dealers return them to supplying centre at their own cost and in the same condition received by them within 15 days from the date of dispatch from the Company duly certified by Manager.
 - g. The Company will not accept any responsibility whatsoever for sales made by dealers of goods whose label and / or seal are not intact. The customer should scrutinize the seal, label etc. before purchasing the medicines.
 - h. Drug License number and the date of dealer should be informed while placing order for goods as per Drugs Act and other relevant statutory provisions.
 - i. Bills will be prepared according to the price prevailing at the time of dispatch of goods irrespective of date of receipts of orders.
 - j. Bill will be prepared at the trade prices or as per Company policy.
 - k. For the purpose or any other scheme only the actual sales will be considered irrespective of the value of order placed.
 - l. Goods once sold will not be taken back. However, the company may accept any goods back entirely as its discretion. In any case, goods will not be taken back after six months of supply.
